Statement of Faith
July 7, 2009

- We believe that Scriptures of the Old and New Testaments are the verbally inspired Word of God, inerrant in the original writings, infallible, the final authority for faith and life.

II Timothy 3:15-16 "All Scripture is God-breathed and is useful for teaching, rebuking, correction and training in righteousness, so that the man of God may be thoroughly equipped for every good work."

- We believe that there is one God, eternally existent in three persons equally as God the Father, God the Son (Jesus Christ), and God the Holy Spirit.

Matthew 3:16-17 "As soon as Jesus was baptized, he went up out of the water. At that moment heaven was opened, and he saw the Spirit of God descending like a dove and lighting on him. And a voice from heaven said, "This is my Son, whom I love; with him I am well pleased."

- We believe that only Jesus Christ the Son lived a life without sin. All other people are sinners in need of salvation.
